- Student must be a Georgia resident.
- Student must have completed the admissions requirements for SCTC and be admitted as a full-time or part-time student for the upcoming semester.
- Student must submit a completed application with attachments. Illegible or incomplete applications will NOT be considered.



## SCHOLARSHIP INFORMATION

The **GED/Advancement-to-College Textbook Scholarship** is a \$250 textbook scholarship awarded to a recent Southern Crescent Technical College GED graduate who scored over 500 on the GED test and who has enrolled part-time or full-time in Southern Crescent Technical College to begin work on a certificate, diploma, or degree program of study. The scholarship funds are not paid directly to the student. The \$250 award is used to set up an account in the student's name with the SCTC Bookstore. The scholarship pays for **course-required textbooks only**. Any funds not used during the awarded semester will be returned to the Foundation scholarship fund.

## DISQUALIFICATION POLICY

If the student withdraws or drops a class at any time or for any reason during the semester which results in the student no longer having at least part-time status and/or the student does not complete the semester, the student should contact the Advancement Office immediately. The student may be responsible for re-payment to the Foundation.

If payment is not made by the student, the College will place a "hold" on the student's record, and the student will be ineligible for this scholarship in the future.
